YOUR AGM QUESTIONS

Why do I get AGM information?

When you save or take out a mortgage with us, you become a member of the Society. This means we're accountable to you and one of the ways you can have a say on how the Society is run is by voting at the AGM.

Does my vote make a difference?

Your vote has an impact on important decisions, for example a director will only be elected if the majority of members who vote, vote in their favour.

If you voted last year, thank you – you helped raise £25,000 for FareShare, our charity partner. This year we'll donate 35p for every online vote and 20p for every postal one to FareShare, up to a maximum of £25,000.

How can I join in or watch the AGM online?

You'll be able to watch the AGM live online at 2.30pm on Tuesday 29 April 2025. You can also vote and ask questions. Votes cast during the meeting will be used as your final vote, even if you have already voted by post or used the online voting site.
